Overview

This annual report, required by Ark. Code Ann. § 20-77-2509(a), summarizes the activities of the Office of Medicaid Inspector General (OMIG) for the preceding calendar year: January 1, 2024, to December 31, 2024. OMIG opened 80 fraud investigations, conducted 572 audits and related activities, initiated 60 administrative actions, referred 43 cases to prosecutors or licensing authorities, identified \$17,421,224.70 of Medicaid funds for recovery, and recovered \$7,411,596.74.

Investigations

OMIG opened 80 and completed 39 investigations. Details on each investigation are attached. OMIG receives leads for investigation through audits, public complaints, self-reports by Medicaid providers, referrals from external agencies, and referrals from law enforcement agencies, including the Attorney General's Medicaid Fraud Control Unit (MFCU). OMIG continues to use data analytics to identify fraud, consistent with national and federal program integrity trends.

OMIG works closely with the Special Investigative Units of the Medicaid Managed Care Organizations (MCOs), including the Provider-Led Arkansas Shared Savings Entities (PASSEs). These entities refer providers to OMIG when their investigations and audit teams identify potential fraud.

Audits

OMIG initiated and completed 572 audits and audit activities. This includes 37 desk audits, 127 contractor audits, 203 recoupment letters, and 205 reviews. Details for all audits and audit activities are attached.

Administrative Actions

OMIG initiated 60 administrative actions against providers in 2024, which included 40 suspensions and 20 exclusions. Administrative actions include sanctions such as suspension from payment of Medicaid claims and exclusion from participation in the Medicaid program. These actions are detailed in the attachments.

Referrals

In 2024, OMIG made 43 referrals to licensing authorities or for prosecution to the Attorney General, which resulted in four arrests due to a credible allegation of fraud. One provider was referred to the MFCU civil division. These referrals are detailed in the attachments.

Educational Activities

OMIG conducted an annual training session attended by PASSE Special Investigation Units, MFCU, and the Department of Human Services. In addition, OMIG staff attended the National Association for Medicaid Program Integrity, the National Healthcare Anti-Fraud Association State Information Sharing Session, the Central Arkansas chapter of the American Academy of Professional Coders, Arkansas Foundation for Medical Care Workshops, and the Healthcare Fraud Prevention Partnership.

Office Performance

OMIG's total dollars identified for recovery in 2024 were \$17,421,224.70 and total dollars recovered were \$7,411,596.74, as detailed in the chart below. Recoveries will often be less than identified overpayments for several reasons. Many providers submit requests for reconsideration and appeals, which can reduce the amount owed or delay its recovery. At times, identified amounts become unrecoverable, such as when a provider goes out of business.
